The applicant:

Consent to the processing of special types of data:

Special type of personal data (racial or ethnic origin; political, religious or other beliefs; social origin; membership in trade unions; data related to health status; sex life or sexual orientation; data formed according to court records; data from misdemeanor or criminal records) are data that the Controller can only process based on your consent. They are necessary in order to achieve the aforementioned purpose of processing your personal data. Consent is given voluntarily and can be revoked at any time, in the same way it was given. Revocation of consent does not affect the admissibility of processing that was carried out on the basis of consent before the revocation. In case of revocation, the Controller has the right to compensation for justified costs and damages incurred. Failure to give the consent to the processing of special types of personal data results in impossibility of resolving the request for payment of compensation and its rejection.

In terms of the law that determines the protection of personal data, with my signature I confirm that I have been previously informed about the identity of the Controller, about the contact details of the person for the protection of personal data, about the purpose of data collection and processing, the way of using the data, about the recipients of the data, the legal basis of the processing, the right to revoke the consent to processing and the rights related to unauthorized processing, that I have carefully read the notice on the processing of personal data with special types of data and that I agree to the processing of the same.
